New Commissioner Orientation

- You as a Regulator, will have to go to great lengths to never get yourself, your commission, your staff, state, or tribe into a relationship that would give the perception of impropriety. Like......
- Posing for photos with fighters, promoters, etc...
- Allowing for special privileges.
- Accepting gifts or other favors.
- Never violate a rule, regulation, or statute when in the process of regulating an event and this will never be an issue.
- You have statues, rules and regulations in place to prevent this from happening. Do not be afraid to say NO!!
- Support your decisions and be confident that you are making the right call based on your jurisdictions laws, rules, and reg's.

ETHICS

- Developing professional relationships with promoters and fighters is necessary, however, careful attention needs to be paid to not allow these relationships to affect you in the performance of your duties as a regulator.
- Common sense will always prevail. Use your head and make decisions based on what you jurisdiction deems within statute and regulation.

Federal ID Cards & MMA National ID

- ID numbers are issued by BoxRec and MMA database.
- ID are issued by State Commission in which the fighter resides
- Confirming the ID of the fighter is critical to ensuring health and safety of all involved.
- Fighters attempting to obtain a FED ID under fake names and info is a real thing. It's up to the commissions to prevent it.

Suspensions

Do not, under any circumstance, allow a fighter that is suspended buy another commission to participate in a event until the suspension has been lifted and/or cleared by the commission that issued the suspension. EVER!!!!

Medical Issues

- Hydration
- Weight cuts
- Medical release forms make commission to commission medical request more manageable.
- Medical suspensions need to be cleared by your commission doctor.
- You MAY NOT lift a medical suspension levied by another commission. The suspending commission must do it.

Match-Up and Bout Decisions

- Health and safety is your first concern.
- Common sense prevails in most cases. Trust your gut instinct. When in doubt call someone. We all do it and its encouraged rather than frowned upon.
- **Do not** be afraid to say no. EVER!!!!
- You are the regulatory authority, not the promoter.
- Approving a mismatched bout has ramifications well beyond the bout alone.
- Sometimes its you job to protect the fighter from him/her self.
- Examples.....Mis-matches ect...

Suspensions

- It is the responsibility of the <u>fighter</u> to adhere to all requirements set forth by the suspending commission to have his or her suspension lifted or cleared.....Not yours!!!
- Health & Safety could not be more important in this situation.
- No clean fighter page...No fight....No exceptions.

Working with Other Commissions

- Developing good relationships with other state and tribal commissions is a key component to regulating these sports.
- We all have "go to" commission heads that we call for questions and requests. Having positive relationships with these people makes our job easier.
- Answer your phone. If a commission is calling at 5:30 on a Friday night, it's probably not to chat....It's more than likely an issue with a fighter they are about to put on a scale.
- Make sure your contact info is correct on the ABC website.
