










### **US Pro-boxing Suspensions**





#### **US Pro-boxing Suspension Violations**




- The number of violations are declining as bouts are recovering
- Alert system introduced 2020




### **US Pro-boxing Suspension Lengths**

- The "other" category highlights that a significant number of suspensions of adhoc lengths are being issued


30/6/2018 - 30/6/2019





#### Requirements System


#### Boxers with at least ONE recorded requirement met

### **US Bouts per Sport**




- Matchmakers now entering 70% of bouts

- Suspension violations reduction


